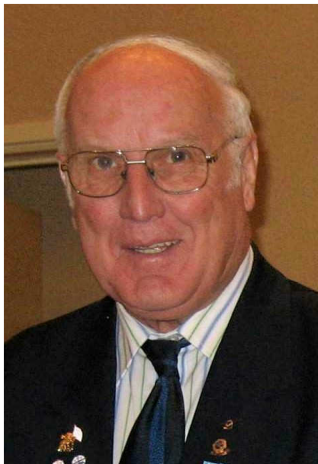

THE TWO LIONS NSW-ACT FOUNDATIONS

The purpose of the various Lions charitable Foundations are frequently a source of confusion within Clubs. As a result, the two Lions NSW-ACT Foundations are sometimes overlooked by Clubs as a possible source of funding assistance towards their community sight, medical and/or health related projects.

All the various Lions charitable Foundations were established as a result of resolutions passed by the delegates attending either a Lions International, or Multiple District, or District Convention. The *Lions NSW-ACT Save Sight Foundation* and the *Lions Clubs NSW-ACT Public Health Care Foundation* were established as a result of resolutions passed by the delegates attending the Conventions of the Districts located wholly within the boundaries of NSW and the ACT, often referred to as "the 'N' Districts" and were adopted as a District 201 N4 project. All Clubs within the District are automatically members of the Foundations.

Lions NSW-ACT Save Sight Foundation

The Foundation was established in 1974 and since then has funded grants worth over \$4.5 million.

As its name implies, the Foundation's purpose is to save sight, and this is achieved through the funding of research into eye care and the causes, diagnosis, prevention and treatment of diseases of the eye. This is achieved through the provision of grants towards research projects; the purchase of equipment for universities, hospitals and institutions involved in eye health; equipment for the visually impaired; and the promotion of eye care in the wider community.

The Foundation provided the University of Sydney's *Save Sight & Eye Health Institute* with seed funding to assist in its establishment. *The Lions NSW Eye Bank* was an initiative of the Foundation that was established in partnership with the NSW Government and the then Sydney Area Health Service. The Foundation currently contributes \$100,000.00 annually towards the running costs of the *Lions NSW Eye Bank*.

Lions Clubs NSW-ACT Public Health Care Foundation

The Foundation was established in 1981 with the primary objective of promoting, advancing and assisting research into the causes, diagnosis, prevention and treatment of illnesses, sicknesses and afflictions of all kinds suffered by humans.

Since its establishment, the Foundation has funded grants worth over \$4 million towards research projects concerning various health and medically related matters; funding for the purchase of equipment for universities, hospitals and other health institutions; and for the promotion of health matters in the wider community.

201N3 Charlestown Lions supporting dialysis patients



Thanks to a \$50,000 donation from the Lions Clubs NSW-ACT Public Health Care Foundation and Charlestown Lions Club, people undergoing treatment at the Wansey Dialysis Centre at Charlestown will soon be enjoying the comfort of 10 new dialysis chairs.

Each week, the Wansey Centre provides kidney dialysis treatments for approximately 80 renal failure patients from the Greater Newcastle area and beyond. These patients need to sit in a dialysis chair for up to six hours three times a week.

Charlestown Lions Club President Michael Morris said the Lions Club donation is in response to a fundraising initiative by the Hunter and Northern Kidney Association (HANKA) to replace the centre's twenty two dialysis chairs.

"The Lions Club is pleased to support HANKA in their efforts to buy new dialysis chairs to improve the comfort of people undergoing dialysis treatment at the Wansey Centre," Mr. Morris said. "Locally, the Charlestown Lions Club donated \$10,000 towards the new chairs and we were successful in applying for a grant from the Lions Clubs NSW-ACT Public Health Care Foundation for another \$40,000."

The new fully motorised dialysis chairs have adjustable seats, back rests and leg rests, and removable arms that allow side entry for people in wheelchairs. They also have the benefit for nursing staff of being height adjustable. Community Dialysis Services Nurse Manager Kelly Adams said the new chairs will significantly improve the comfort and independence of dialysis patients. "Many of our patients are frail or have limited mobility and they need a nurse to help them adjust the current dialysis chairs," Ms Adams said. "These new chairs will do a great deal in making the patient's dialysis experience more pleasant by allowing them a greater degree of independence to reposition themselves during treatment. "We are extremely grateful to Charlestown Lions Club and Lions NSW- ACT Public Health Foundation for their generous donation."

The total GST exclusive cost of the project is \$6,580.72, with the deficit covered by \$1,500.00 contributed by the applicant. (N1) - up to **\$69,500.00** towards the purchase of an **Alcon Infiniti Vision System Phacoemulsifier Machine & Accessories** and a **Keeler Cryomatic Cryotherapy Surgery System & Accessories** for the Tamworth Rural Referral Hospital. The total GST exclusive cost of the project is \$102,500.00, with the deficit covered by \$3,000.00 contributed by the hospital's Ladies Auxiliary, \$20,000.00 from fundraising conducted by the hospital's operating theatre nursing staff, and \$10,000 contributed by the applicant. The DGR endorsed Grantee is the Hunter New England Area Health Service.

No. 227. Save Sight Institute. Consideration deferred until the November meeting pending receipt of further information.

No. 228 - Lions NSW Eye Bank - up to **\$2,500.00** per calendar year for 5 years towards the **cost of staff attendance at work-related training and conferences**. The sum of **\$2,156.92** was approved for payment for expenses incurred in the first half of 2008 in relation to the expenses of 4 staff members' attendance at work-related conferences and training in Sydney, Melbourne and Brisbane. The Grantee is the Save Sight Institute.

No. 229 - Lions NSW Eye Bank - up to **\$757.00** towards costs associated with the holding of the **2008 Eye & Tissue Remembrance Service**, for the families who donated the eyes of their deceased family members for corneal transplantation to the Lions NSW Eye Bank, to be held in the Concord Hospital Memorial Chapel. The Grantee is the Save Sight Institute.

The total GST exclusive cost of the project is \$10,990.00, with the deficit covered by \$1,500.00 contributed by the applicant. The DGR endorsed Grantee is the Hunter New England Area Health Service.

No. 541 - Lions Club of Gungahlin Inc. (N2) - up to **\$1,700.00** towards the purchase of a **Dejay AB-430 Junior Section Change Table** for the Disability Program of the Gungahlin Regional Community Service Inc. The total GST exclusive cost of the project is \$3,626.00, with the deficit covered by \$1,926.00 contributed by the applicant. The DGR endorsed Grantee is the Gungahlin Regional Community Service Inc.

No. 542 - Lions Club of Charlestown Inc. (N3) - up to **\$40,000.00** towards the purchase of **10 x Thompson Maxilift 2 Dialysis Treatment Chairs** for the Wansey Community Dialysis Centre, Charlestown. The total GST exclusive cost of the project is \$50,000.00, with the deficit covered by \$10,000.00 contributed by the applicant. The DGR endorsed Grantee is the Hunter New England Area Health Service.

No. 543 - Lions Club of East Gosford Inc. (N3) - up to **\$10,000.00** towards the **Conversion of a Van & Supply & Fitting of a Hydraulic Wheelchair Hoist** for the use of a quadriplegic woman. The total GST exclusive cost of the project is \$19,345.00, with the deficit covered by \$9,345.00 contributed by the Australian Lions Foundation (ALF). The DGR endorsed Grantee is the Coast Community Care Inc.

No. 544 - Lions Club of Nambucca Heads Inc. (N1) - up to **\$1,990.00** towards the purchase of a **Pegasus Viaclin Dynamic Mattress System** for the Macksville & District Hospital. The total GST exclusive cost of the project is \$3,990.00 with the deficit covered by \$2,000.00 contributed by the club. The DGR endorsed Grantee is the North Coast Area Health Service.

No. 545 - Lions Club of Singleton Inc. (N3) - up to **\$13,000.00** towards the purchase of **3 x Thompson Maxilift 2 Treatment Chairs** for the Haemodialysis Unit of the Singleton District Hospital. The total GST exclusive cost of the project is \$15,600.00 with the deficit covered by \$2,600.00 contributed by the club. The DGR endorsed Grantee is the Hunter New England Area Health Service.

(N3) - up to **\$10,000.00** towards the cost of **3 x Regency Healthcare Electric Hi-Lo Beds & Accessories, 1 x Proact Medical Systems Datascope Trio Cardiac Monitor, 1 x Welch Allyn Examination Light & Mobile Stand, and 1 x Arjo Tempo Power Patient Lifting Hoist & Accessories** for the Muswellbrook District Hospital. No. 547 - Lions Club of Ingleburn Inc. (N2) - up to **\$2,900.00** towards the purchase of an **Animas Insulin Pump 2020** for the use of a 63 year old woman with Type 1 Diabetes. The total GST exclusive cost of the project is \$5,400.00 with the deficit covered by \$500.00 contributed by the club and \$2,000.00 contributed from other sources. The DGR endorsed Grantee is the Myrtle Cottage Group Inc.

No. 548 - Lions Club of Liverpool City Inc. (N2) - up to **\$2,990.00** towards the purchase of an **Aruba 4 Motorised Mobility Scooter** for a 33 year old man with Multiple Sclerosis. The total GST exclusive cost of the project is \$4,990.00 with the deficit covered by \$2,000.00 contributed by the club. The DGR endorsed Grantee is the Sydney South West Area Health Service.

NEW GRANT APPLICATION FORM

The Grant Application Guidelines have undergone a major revision and now appear on page 2 of the Grant Application Form. (also a copy on page 6 of this issue of Perspective)

The current Grant Application Form can be identified by the notation *Form Revised August 2008* printed in small type at the bottom left of page 1.

Earlier versions of the Grant Application Form should be discarded. The Foundations' Policy Minute 8(a) states in part that, "Grant applications not using the current form will be returned along with a copy of the current form and the applicant requested to resubmit."

FOUNDATIONS' WEBSITE

The Foundations' website has been given a new look and updated with the latest current information. (Webmaster, PDG John Sim.) I thank PDG John for his good work.

The need by public hospitals and other health related institutions and the like for funding to upgrade existing equipment and purchase new equipment is always greater than the government funding available to service the need.

In these times of economic uncertainty, the support of clubs in continuing to help build the Foundations' capital base is needed more than ever, as grants can only be funded from the income earned on the investment of the Foundations' capital.

TANYA NOBLE PROJECT (A GREAT 201N3 ZONE 1 PROJECT)



The Toyota Commuter Bus with the Ricon wheelchair lift was delivered to Tanya and her family on Thursday 1st May. The excitement generated within the family was a joy to observe. Paul and Gail Noble (Tanya's parents) are so relieved to have the convenience of being able to transport Tanya themselves; Tanya is on top of the world knowing that she can now have her electric wheelchair (her independence) with her if she has to go into hospital (just one example); the family can now enjoy outings together as a whole new world of opportunity has opened up.

Members of the family have repeatedly expressed their gratitude to Lions and to Coast Community Care who we worked with to make this project happen.

Just to remind you. The total project required more than \$55,000.

The Coast Community Care local fund raising effort raised \$30,000.

All Clubs from Zone 1 of 201N3 participated with a total contribution of \$6,000.

Australian Lions Foundation provided a grant of \$9,345.

Lions NSW-ACT Public Health Care Foundation provided \$10,000.

Lion's involvement went way beyond our financial contribution. We were able to provide advice and assistance with fund-raising; we were able to help with research on the vehicle and the conversion; we were successful in sourcing a more appropriate vehicle than originally specified and as a result of our involvement we found a vehicle in Australia which meant we did not have to wait the expected 5 months for delivery from Japan.

The vehicle was purchased from Brian Hilton Toyota in Gosford and they are providing free service for the three year warranty period. The Ricon wheelchair lift was purchased from Steve Rogers of Safe Travel Solutions (Gosford) and he has decided to match the Hilton offer by providing free service on the lift.

The project has been a great collaboration between the community, local business, local Lions Clubs, a NSW-ACT Foundation and an Australian Foundation - a fabulous Lions effort.

ALL CLUBS PLEASE NOTE THE CONTRIBUTION FROM OUR LIONS FOUNDATIONS. BECAUSE WE WERE ABLE TO SPEED UP THE DELIVERY TIME, WE NEEDED THE GRANTS MORE QUICKLY THAN EXPECTED AND BOTH FOUNDATIONS EXPEDITED THE PROCESS - WE SINCERELY THANK THEM FOR THAT. WE ENCOURAGE ALL LIONS CLUBS TO SUPPORT THE FOUNDATIONS SO THAT OTHERS CAN BENEFIT FROM THEIR SUPPORT.

Once again, a **BIG THANKYOU** to everyone who helped to make this project happen.

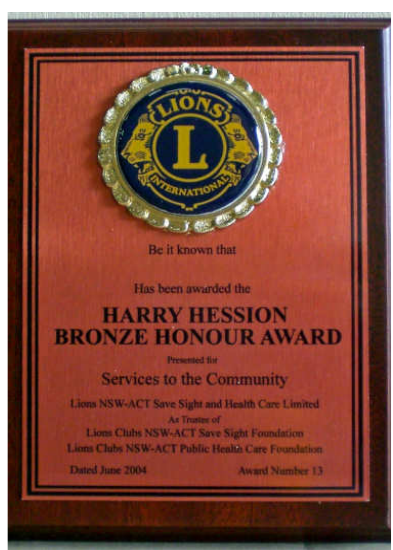

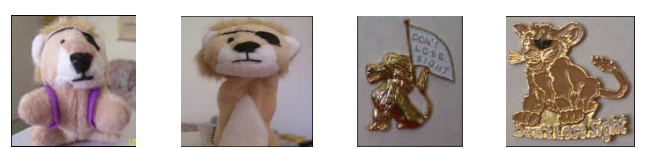

New Grant Application Guidelines

- (a) Read these guidelines carefully and ensure all sections are completed correctly. An explanation must be included in the applicant's covering letter if compliance of any guideline is not full and complete. Contact your District Directors for advice on completing the application. Their details are in the current MD Directory.
- (b) Both ordinary and research grants are confined to funding assistance to eligible funds, authorities or institutions, and relating to projects of sight, medical and/or health issues. Grants cannot be paid to individuals.
- (c) A grant application for a project should be formally adopted by the club's Board of Directors and the form signed by any two (2) of the President, Secretary or Project Chairman, or failing them, two (2) members of the Board of Directors. Region and/or Zone Chairmen are to sign applications where applicable.
- (d) If a grant application is for funding towards the purchase of equipment, detailed fully itemised quotes from at least two (2) suppliers showing the GST EXCLUSIVE costs of each item are to be obtained and accompany the application. The Grantee funds any applicable GST component and is able to claim it back on their BAS. A separate written explanation must be given if two (2) independent quotes for each item of equipment are not provided.
- (e) Consideration of a grant application will be hampered and may ultimately be refused unless evidence is provided showing genuine efforts having been made by the applicant to obtain funding from other relevant sources, including the club's resources, before submitting the application. (Information and some other funding sources may be found at www.communitybuilders.nsw.gov.au).
- (f) Directors' meetings are held in March, August and November of each year. In order to be considered at the next meeting, completed grant application forms and all supporting documentation must be submitted to one of your Foundation Directors for their perusal and signature by the fifteenth (15th) day of February, July or October at the latest, otherwise the application may be held over to the following meeting. Grant applications should be lodged as early as possible. Grant requests of not more than \$3,000.00 GST exclusive need not wait for a Directors' meeting to be considered.
- (g) Applicants for grants are expected to contribute to the cost of the project for which the grant application is being made.
- (h) A grant application towards a research project and/or equipment purchase may be made directly to the Foundation by an acceptable research institution. The application must be signed by the Director of the research institution and the person to head the research project. If possible, a Lions' member should also sign the application prior to a Foundation Director receiving it for their perusal and signature.
- (i) A full résumé by way of a covering letter from the applicant, club or institution must be attached to every grant application. The letter should include details of the circumstances which lead to the submission of the grant application, details of the investigation, and any other issues of importance. Copies of written confirmation of all successful funding sources and pledges towards the project need to be included.
- (j) A grant application to fund building construction cannot be considered.
- (k) A grant application cannot be considered if the application is for reimbursement of any project that has commenced or has already been funded. Grants approved by the Foundation cannot be paid until the itemised Tax Invoices (or certified copies thereof) made out to the Grantee from the supplier of the goods or services have been received by the Foundation.
- (l) A grant approved by the Foundation Directors is subject to the condition that it is to be taken up within twelve (12) months from the date of approval, whereupon it will lapse. The applicant will have the right to re-apply and/or seek an extension of time. Any request for an extension of time must be in writing and include a full explanation which must be lodged prior to the approval lapsing.
- (m) Submission of a grant application should not be taken as an approval. Applicants will be informed in writing as to the decision of the Foundation's Directors.
- (n) If the application is for a research project, thirty (30) copies of details of the project must be included with the grant application for evaluation by an independent professional committee and distribution to the Foundation's Directors.
- (o) If a grant is approved for a research project, thirty (30) copies of an up-to-date progress report on the project must be forwarded to the Foundations' Secretary by the first (1st) day of March and August for distribution.
- (p) Applications not correctly submitted may not be considered until the guidelines are fully met. If you have any problems in submitting your Grant Application, contact one of your Foundation Directors for assistance. They are here to help.
